

STATE OF MINNESOTA	RESOLUTION VACATING A PORTION OF 10TH STREET SE LOCATED IN THE WEST HALF OF THE COMMON BOUNDARY LINE OF SECTIONS 2 AND 11, AND 60TH AVENUE SE LOCATED IN THE NORTH HALF OF THE COMMON BOUNDARY LINE BETWEEN THE NORTHWEST QUARTER (NW ¼) OF SECTION 11 AND THE NORTHEAST QUARTER (NE ¼) OF SECTION 10, ALL IN MARION TOWNSHIP
COUNTY OF OLMSTED

WHEREAS, a motion of the Marion Town Board of Supervisors to vacate a portion of 10TH Street SE located between the western right-of-way line of Olmsted C.S.A.H. No. 119 and the western right-of-way line of 60th Avenue SE located on the Common Section Line between the Northwest Quarter (NW 1/4) of Section 11 and the Southwest Quarter (SW 1/4) of Section 2; and a portion of 60th Avenue SE located between the north right-of-way line of 10th Street SE and the north railroad right-of-way line located on the Common Section Line between the Northwest Quarter (NW ¼) of Section 11 and the Northeast Quarter (NE ¼) of Section 10, all in Township 106 North, Range 13 West, Olmsted County, Minnesota, was made on July 12, 2016, by the Marion Town Board of Supervisors;

AND WHEREAS, upon making said motion, we did make out a notice of hearing and fix therein a time and place at which we could meet and act upon such motion; to-wit: On the 10th day of August, A.D., 2016, at 8:15 p.m., at the Marion Town Hall, causing such notice to be published for two weeks before such meeting and providing mailed notice to all adjacent property owners, and having met at such time and place above-named in said

notice, we heard any and all reasons for or against vacating the same, and being of the opinion that such vacation was necessary and proper, and in the public interest, we unanimously voted and determined to vacate a portion of 10th Street SE and 60th Avenue SE and the same is hereby vacated; the description of which was vacated is as follows, to-wit:

A portion of 10TH Street SE located between the western right-of-way line of Olmsted C.S.A.H. No. 119 and the western right-of-way line of 60th Avenue SE located on the Common Section Line between the Northwest Quarter (NW 1/4) of Section 11 and the Southwest Quarter (SW 1/4) of Section 2; and a portion of 60th Avenue SE located between the north right-of-way line of 10th Street SE and the north railroad right-of-way line located on the Common Section Line between the Northwest Quarter (NW 1/4) of Section 11 and the Northeast Quarter (NE 1/4) of Section 10, all in Township 106 North, Range 13 West, Olmsted County, Minnesota,

IT IS THEREFORE ORDERED and determined that said Right-of-Way in a portion of 10TH Street SE located between the western right-of-way line of Olmsted C.S.A.H. No. 119 and the western right-of-way line of 60th Avenue SE located on the Common Section Line between the Northwest Quarter (NW 1/4) of Section 11 and the Southwest Quarter (SW 1/4) of Section 2; and a portion of 60th Avenue SE located between the north right-of-way line of 10th Street SE and the north railroad right-of-way line located on the Common Section Line between the Northwest Quarter (NW 1/4) of Section 11 and the Northeast Quarter (NE 1/4) of Section 10, all in Township 106 North, Range 13 West, Olmsted County, Minnesota, be and the same is hereby vacated according to the description last aforesaid.

IT IS FURTHER ORDERED that the Marion Town Clerk shall prepare a Notice of Completion of Vacation Proceedings and present it to the Olmsted County Auditor (Administrator of Property Records and Licensing) who shall enter it in the transfer records and note upon the Notice, over the Olmsted County Auditor's signature, the records "entered in the transfer record", and then file the Notice with the Olmsted County Recorder.
