Storm Water – No discussion

Fire Contract — Roger provided a timeline of City of Rochester fire contract negotiations to date. Another round of discussions between the City of Rochester and Townships is scheduled for March 14, 2025.

Roads – We have taken 4 semi loads of salt this year; our salt shed is presently full. 60th Avenue (hill) has a lot of sand and needs to be swept. A M/M/S by Bjerke/Messmer for Wigham to sweep 60th Avenue. 3 yes. Tree trimming is almost complete and came in under budget. A M/M/S Schoenfelder/Bjerke to clean ditches and tree trimming on 10th St. SE, near Donlingers and possibly 30th Street. 3 yes. Culverts on Pagel Drive and on Marion Place need to be inspected at time of road inspections.

Dog Bite – Ben King reported their findings on the recent dog bite in Chester Heights Street SE. The investigation warrants classification as a potentially dangerous dog. Dunlap will send a letter to the dog owners.

Noise Ordinance – Residents presented with a sheriff's incidence report and violation of Township Noise Ordinance and an overweight semi.
